

# WORD OF THE MONTH: JESUS

This year, with Easter on the last day of March, also overflowing into April in terms of public holidays, I experienced a feeling of receiving a double portion.

Six times in the Bible, specific reference is made to a "double portion." When someone receives a double portion, he gets a gift twice as much as the measure given to others.

Near the end of Elijah's time on earth, he offered his assistant Elisha a gift: "What can I do for you before I am taken from you?" Elisha answered, "Please let there be a double portion of your spirit on me" (2 Kings 2:9).

Another example is Isaiah 61:7: "Instead of your shame there shall be a double portion; instead of dishonor they shall rejoice in their lot; therefore in their land they shall possess a double portion; they shall have everlasting joy."

Every year I am overwhelmed by God's undeserved generosity, made available to us through Jesus Christ, our salvation. Through Jesus we are forgiven, the debt of sin is paid and we are received in the family of God, our Father, heirs of His kingdom everlasting, being granted eternal life. Is this double portion? My sense is that this is so much more, a thousand-times more than double. And how do we receive this godly provision upon us? Just believing that Jesus is salvation:

"I am the way and the truth and the life. No one comes to the Father except through me." John 14:6

May we rejoice in the knowledge that, through believing in Jesus Christ, we are saved!



## PASTORAL MESSAGE: JESUS OUR SALVATION

There is no other issue in our Christian faith more important than Jesus, Our Salvation. It is the central focus of our faith and often criticised by people in the world who are not established in faith in Christ. What I mean by this is that our modern world criticises faith in Christ as narrow-minded and intolerant: how can we Christians make such an exclusive claim that Jesus is the only means of salvation? What about other religions – are not their truth-claims just as valid? And what about those who have never heard of the Gospel?

The answer to those questions is not in the perspective of those who do not have faith in Christ, but in Christ Himself. Jesus said in John 14:6, "I am the way, the truth, and the life. No one comes to the Father except through me." The exclusive claim to salvation is rooted in Jesus' very own words. Later on, the Early Church through the writings of Paul embraced this exclusive claim by Christ. Paul the apostle wrote in Galatians 2:16, "Knowing that a man is not justified by the works of the law but by faith in Christ Jesus"; and also in Romans 1:16, "For I am not ashamed of the gospel of Christ, for it is the power of God to salvation for everyone who believes."

The apostle Peter's statement affirming this truth-claim of exclusivity in salvation is also noteworthy; he declares to the anti-Jesus, Jewish leaders of his day, "Nor is there salvation in any other, for there is no other name under heaven given among men by which we must be saved." I understand the statement "name **under** heaven" to mean that the name, Jesus, possesses the fullness of the authority of heaven, and in the context of the verse it is specifically for the salvation of humanity.



Another issue worth exploring in the title, "Jesus Our Salvation", is the definition of salvation itself. What is meant by the Bible in the word salvation? Or in the word "saved"? A straightforward definition of salvation ("soteria" in Greek) by the commonly used Strong's theological dictionary defines it as "rescue or safety (morally or physically): deliver, health, salvation, save, saving. The word "save" or "saved" ("sozo" in Greek) is defined by Vine's theological dictionary as (a) material and temporal deliverance from danger, suffering, etc,; (b) the spiritual salvation granted immediately by God to those who believe on the Lord Jesus Christ; (c) the present experience of God's power to deliver from the power of sin; and many other definitions of "saved" itself and other words derived from "sozo". My point in raising these definitions is to show

you that salvation is not just our ticket to heaven, as I think salvation is often narrowly defined, but that it is also heaven's ticket to us here on earth, in our day-to-day lives. In salvation, God's power is effectively operating and saving us everyday – delivering us from evil and sin, protecting us from the attacks of our spiritual adversary, and, in many real ways, healing us emotionally and physically. Jesus our Salvation is truly heaven on earth, with greater experiences of salvation still to be experienced by the saved!

### AGED CARE WORKERS WIN UP TO 28.5 PER CENT WAGE RISE

Aged care workers have won their years-long Fair Work case for a wage rise of up to 28.5 per cent for the entire sector.

In November 2020, the Health Services Union (HSU) filed a work value case with the Fair Work Commission (FWC) regarding aged care that requested a 25 per cent increase in wages for all employees.

The union argued that the work had been undervalued due to its growing complexity and the fact that it was primarily performed by female workers.

"We find that the work of aged care sector employees has historically been undervalued, because of assumptions based on gender," the FWC's decision said.

It based that finding on historical gender assumptions made when wages were fixed in awards, and that many historical issues were migrated across to the modern awards system.

The commission awarded an interim pay rise of 15 per cent to direct care employees in 2022, but the union maintained wages were still insufficient and would not address a critical shortage of aged care workers.

The hourly wage for direct care workers will increase between 18 and 28 per cent, inclusive of the previous 15 per cent, resulting in a significant impact on pay.

### WORKERS DESERVE RESPECT AND BETTER PAY, SAYS PRIME MINISTER

The decision affects more than 200,000 residential and home care workers.

Higher wages were a key recommendation of the Royal Commission into Aged Care Quality and Safety,

A federal government task force recently reported on how to reform the sector for the future, including recommendations to make wealthier Australians pay more for their care.

Prime Minister Anthony Albanese said he learnt from the Royal Commission into aged care that "we need to pay our aged care workers more, in order to keep and retain staff".

"It is vital that our older Australians get dignity and respect in the later years. The workers who look after them deserve respect as well and they deserve better pay."

"We have already increased aged care workers wages by 15 per cent and we will always work with our aged care workforce in order to improve the life of people who looked after this country for such a long period of time," Mr Albanese said.

In a joint statement the Minister for employment, the Minister for health and the Minister for aged care said they welcomed the FWC decision and that the government was closely examining the content of the decision, which is "lengthy and highly detailed".

"We promised to fight for a pay rise for Australia's aged care workers and we did," the statement said.

"Early in our term we made a submission to the Commission that unequivocally supported a wage increase."

## CARPET CLEANING NO LONGER APPROVED UNDER HOME CARE PACKAGE GOVERNMENT GUIDELINES


# WORD SEARCH ANSWERS

Home care package funds are intended to be used for regular, ongoing care and services related to a client's aging related health care needs.

The Government does not allow home care packages funds to be used for care, items and services that would normally be purchased out of general income (general furniture items, white goods and general home maintenance).

Government guidelines clarified that carpet cleaning is considered a general income expense and should not be covered by Home Care Package funds.



As an exception, to access professional carpet cleaning using home care package funds, Elders should have a care needs assessment which should identify a health condition (such as severe and permanent incontinence) which requires carpets to be regularly professionally cleaned. This should be detailed in the Elder's care plan and home care package budget.

NOTE: Allergies and chronic asthma are considered chronic health conditions, not ageing related, therefore not covered by HCP.


